Nevada Home Health Agencies Receive Award for Quality Care *HealthInsight Program Encourages Excellence in Patient Care*

Las Vegas —Five home health agencies have been awarded the 2011 *HealthInsight Quality Award* for excellence in patient care. *HealthInsight*, a private, non-profit community based organization dedicated to improving the healthcare systems of Nevada, New Mexico, and Utah, sponsors the award. The home health agencies were selected for demonstrating high quality health care and excellence in performance on publicly reported quality of care measures and other specified quality markers. These measures come from data that are voluntarily reported by home health agencies across the nation. According to the Institute of Medicine, transparency in health care is defined as a system that is “accountable to the public, works openly, makes results known, and builds trust through disclosure.” By using available quality data to identify high performing providers and publicizing the results, *HealthInsight* aims to help providers improve health care and help patients become more active and informed participants in that care.
